### GRANT OF LICENSE:

This means you cannot transfer, loan or resell music to any other person or 3rd party at any time. The license is granted only to you, the individual LICENSEE. Any use not specifically approved in this agreement shall be considered to be outside the terms of this agreement. ### APPROVED USES:

This license allows LICENSEE the right to use musical compositions from his or her purchased Triple Scoop Music songs as accompaniment to, or set in synchronization with, the following forms of media:

- a. **PHOTOGRAPHY:** Photo slideshow presentations on the internet (including YouTube, Facebook, Vimeo) or on physical media (CD, DVD, Blu-Ray) used to promote your business. Personal (non-business / non-corporate) photo slideshows with your licensed music may be resold or distributed to individuals (example.
